Part 1: Develop Country Team Action Plans (120 Minutes)

You will have upwards of two hours to pull together all the pieces of an Action Plan on how to proceed when you return to your country on your potential market ideas. Much of the work has completed throughout the two days. The objective of the Group Work is two-fold

- Review the prior Group Work and finalize your ideas
- Develop concrete next steps for the team to achieve in the next 6 months

To following is an outline (and PPT template) to assist the country team to organize and present your Action Plan. The outline follows the MM4H Pathway.

- Diagnosed RMNCAH-N priority challenge and root causes
- Country level platform and stakeholder groups to drive the inclusive process
- Data availability and needs to assess health markets linked to RMNCAH-N priority challenge
- Outline of a market intervention design that addressed the RMNCAH-N priority challenge
- Logic framework measuring the intervention's milestones and success
- Next steps to launch the inclusive process and MM4H pathway to shape a specific health market that addresses the priority RMNCAH-N challenge
